The weather seems to have sent us other challenges in times that are already challenging enough! Our thoughts are with those members of our community who have been adversely affected by this severe weather event.

## **Teaching and Learning Continues**

Thank you for all your support over the last weeks whilst in lockdown. We continue with our teaching and learning at Kaipara College and know that despite the challenges faced, many of our students are doing their very best. The teachers at Kaipara College continue to put work up on the students google classrooms, provide feedback and encouragement, answer questions, stay in contact with students and their families and meet at least once a week on-line with the students.

We are noticing a few gaps at our on-line sessions. These on-line meets are really important for connection, as well as learning. Connection enhances wellbeing and a sense of wellbeing enhances learning. It is in this space that we ask you as parents and caregivers to have conversations with our young people, to assess how they are going, could they do more? Are they doing too much? are they on-line when they need to be? and so forth. I know this is not easy for many families because the adults have their jobs to do too. But I am asking you to keep doing this with your young people if you can, because only together can we maximise our young people's wellbeing and learning in these difficult and trying times.

### Students working during school hours: a message from the Ministry of Education

It's important that young people remain engaged in their learning under the current Alert Level conditions. For students under 16, it is illegal to work during school hours under Section 54 of the Education and Training Act 2020. If employers are putting pressure on students to work during school hours, you may wish to advise them that it is illegal. For older students it is essential that young people remain engaged in their learning so that their future opportunities for work or learning are not impacted. We encourage parents and caregivers to work with their school or kura to ensure young people are engaged in learning rather than being in paid employment during scheduled learning hours.

Our focus as always is to support the learning, safety and wellbeing of our rangatahi and tamariki and we continue to be here to support you as well.

Please don't hesitate to contact your student's whānau teacher, dean or me, if there is something you need assistance with.
